2. Report summary

2.1 Situation

This paper provides an update to NHS Board member nominees for the East and South Ayrshire Integration Joint Boards and seeks Members' approval.

2.2 Background

The NHS Board Standing Orders (6.2b) advises that appointment of Board committee members and membership of Board committees is a reserved matter for Board approval.

The Board Chair reviews representation on Board Committees and IJBs annually, in line with the Non-Executive appraisal process to take into account discussion with individual Non-Executives to consider their views. This ensures good governance practice in the best use of Non-Executive skills and experience across our governance committees. Representation on Board Committees and IJBs is considered in year if required.

2.3 Assessment

Reappointments to IJBs:

- East Ayrshire IJB: Sukhomoy Das, Non-Executive Member, comes to the end
 of his first term of appointment on EA IJB on 28 February 2023. Sukhomoy
 has been nominated for a second term on the EA IJB.
- South Ayrshire IJB: Jean Ford, Non-Executive Member, comes to the end of her first term of appointment on SA IJB on 28 February 2023. Jean has been nominated for a second term on the SA IJB.

The Board Chair is reviewing the committee vacancies that will arise when Bob Martin, Vice Chair, comes to the end of his term on 30 April 2023 and proposals will be presented to a future Board meeting.
