# 2.3 Briefing - Good News Stories

#### Tranquil new garden at NHS Ayrshire & Arran's Kyle Chemotherapy Unit

A garden redesign project led by NHS Ayrshire & Arran's Public Health department, in partnership with a range of key stakeholder including Infrastructure and Support Services, Transformation and Sustainability, Nursing and external partners including RePollinate, Hewlett Packard, Community Justice Services and Impact Arts has recently been launched. Patients attending the Kyle Chemotherapy Unit at Ailsa Hospital are now enjoying the benefits of a new garden after the ward applied to the NHS Ayrshire & Arran Community Wealth Building programme for assistance in making their green plans a reality.

NHS Ayrshire & Arran has included a community benefit requirement into its procurement contracts and tenders since 1 April 2023 to help deliver a wide range of economic, social and environmental benefit projects in Ayrshire and Arran.

Officially opened on 4 July 2025, the garden space at Kyle Chemotherapy Unit has been redeveloped through community benefit funding provided by Hewlett Packard Inc and designed by RePollinate, a conservation charity which aims to create networks of high-quality pollinator habitats through delivery of new community gardens spaces.

Kyle Chemotherapy Unit new garden now benefits from the addition of new raised beds, planters and paths a range of new plants and trees to increase biodiversity and attract pollinators to the garden. It also includes four colourful steel artwork panels, 'Light Through Leaves', funded by Hewlett Packard Inc. and created by BeSpoke Atelier design studio who were commissioned by Impact Arts, after engaging with patients from Kyle Chemotherapy Unit on their design ideas for the creation of the panels.

South Ayrshire Council Criminal Justice unpaid workers shaped the garden at weekends under guidance from RePollinate to help bring about the transformation of the current outdoor garden into a new fully accessible area for the patients of Kyle Chemotherapy Unit.

Celebrating more than 24 years of volunteer support - NHS Ayrshire & Arran: The Hospital Volunteers of University Hospital Crosshouse recently held their Annual General Meeting (AGM), where they proudly presented NHS Ayrshire & Arran with a cheque for £225,000. This latest contribution brings the total raised by the volunteers since 2001 to more than £5,275,000.

Skills Sector celebrate their first graduates - NHS Ayrshire & Arran: NHS Ayrshire & Arran has congratulated the first graduates from the newly formed programme, Skills Sector. Working in partnership, East Ayrshire Council, Ayrshire College and NHS Ayrshire & Arran formed a new programme Skills Sector which is designed to support young people with learning disabilities and autism spectrum conditions to gain valuable employment skills.

Communication boards promote accessibility and inclusion in South Ayrshire venues - NHS Ayrshire & Arran: More than 20 boards to support communication have been installed across South Ayrshire venues as part of a project led by South Ayrshire Communication Friendly Environments (SACFE), part of the South Ayrshire Health and Social Care Partnership. The boards make the parks, beaches and woodland areas where they've been installed more communication friendly. They include pictures, symbols and words to represent ideas, actions, or needs, making it easier for people to communicate their wants, needs, and feelings. As well as providing help for children and young people to communicate, they can also be used as prompts for adults with dementia.

Fun for all at the Patch party! - NHS Ayrshire & Arran: The Orthoptics team at University Hospital Crosshouse held the first ever Patch Party to highlight World Orthoptic Day on 2 June. The team invited some of their young patients (and their grown-ups) so they could meet other children with eye patches, play games, and do some arts and crafts, such as designing their own patches and glasses case. To coincide with the opening of the new animated film Elio, the orthoptic team also organised an information stand about the condition Amblyopia (commonly known as 'lazy eye) at the Odeon Cinema in Kilmarnock. This took place from Friday 20 June until Sunday 22 June and aimed to help raise awareness for the see4school visual screening programme. Big thanks to Odeon staff, Sophie and Clara for the team set up.

Celebrities join forces to inspire at Scottish Cochlear Implant Programme Education Transitions Day - NHS Ayrshire & Arran: The Scottish Cochlear Implant Programme hosted an Education transitions Day event at the Glasgow University Student Union, drawing support from high-profile figures, including Love Island and Strictly Come Dancing star, Tasha Ghouri. The event welcomed more than 60 young people with cochlear implants from across Scotland, as well as their families, teachers and support teams. The event provided information and support as the young people transition from school to further education or employment.

#### Ayrshire Hospice returns to Racecourse Road site

Ayrshire Hospice has returned to their re-developed home at 35-37 Racecourse Road, Ayr this week, following the successful completion of their capital build project. Since 9 July, all inpatient and on-site clinical services are operating from the newly transformed hospice premises, including the state-of-the-art Inpatient Unit (IPU) and the modern Hub building at the heart of the site. This marks the end of their temporary relocation to East Ayrshire Community Hospital, where they have continued to deliver exceptional palliative and end of life care over the past three years.

# **East Ayrshire Health and Social Care Partnership (EAHSCP)**

#### Summer activities celebrate adults with learning disabilities

In partnership with a number of third sector organisations, our colleagues in East Ayrshire Leisure recently delivered a programme of events and activities for adults with learning disabilities.

The events, which included a tea dance at Dumfries House, inclusive sports days and a music and drama showcase, formed a summer celebration ahead of Learning Disability Awareness Week, which will take place in September.

Lorraine Dick, East Ayrshire Leisure Team Coordinator, said:

"We had a fabulous time at the Dumfries House Tea Dance! This fantastic event brought together adults with learning disabilities from across East Ayrshire for an afternoon of fun, friendship, music and dance. It was a beautiful day and brilliant to see so many people up dancing and giving it their all.

"Our second event was an All Ability Sports Day, which took place on Wednesday 18 June at Ayrshire Athletics Arena in Kilmarnock. Organised by East Ayrshire's Learning Disability Partnership, this event provided the opportunity for senior school pupils and adults with disabilities to try out various sporting activities, including football, badminton, athletics, rugby, archery, boxing, boccia and table tennis. The All Ability Bikes were also available for individuals to try and there were a variety of information stalls.

"Finally, our annual Learning
Disability Showcase took place on Thursday
19 June at Stewarton Area
Centre. Organised by East Ayrshire's
Learning Disability Partnership, this event
celebrates the skills and talents of children,
young people and adults with learning
disabilities through music, dance and
drama. This year there were performances
from The Happy Tappers, UCAN, I-Dance,
Sir Alexander Fleming Centre Community
Choir and Park School. This was a fun-filled
evening for both the participants and
everyone who came along to support the
event."



#### **Dementia Resource Centre celebrates reopening**

Celebrations were in order for staff and service users at Kilmarnock Dementia Resource Centre, which recently reopened following a period of flooding last month.

The centre organised a 'Coffee Catch-up' event to mark the reopening, attended by Provost Claire Leitch and former Provost Jim Todd, as well as a programme of events to coincide with Dementia Awareness Week.

Centre Manager, Sheena Boyd, told us more:

"Our centre had been closed for activities due to flooding which damaged the centre floor in our cafe area. As we have a footfall of over 580 per month we needed to relocate these activities.

"We are so grateful for the support of East Ayrshire Carers Centre, The Killie Community, Secret Garden and the New Laigh Kirk, all of whom allowed us to use their venues and continue providing much needed support to carers and people living with dementia.

"We were delighted that Provost Claire Leitch was able to reopen the centre due to the history of our first opening and tenth anniversary being celebrated with former Provost Jim Todd. Claire came along to our Coffee Catch-up event, which featured live music and the cutting of the cake to declare the centre reopened.

"Over 45 people came along to the Coffee Catch-up. One of our regular centre attendees, who lives with dementia, told us he was so happy to be back and that he loves how "homely" the centre is."

#### Kilmarnock FC charity hosts sports event for all abilities

Kilmarnock Football Club's community outreach charity, The Killie Community, recently welcomed adults and young people with additional support needs to Rugby Park for a day of free, inclusive football and sporting activities.

Around 80 young people and 60 adults from across Ayrshire attended the event, which took place in the football club's stadium and promised to be a fully accessible and inclusive experience.

Jordan Allison, Charity Manager, provided a rundown of the day:

"From 10am to 4pm, the stadium hosted participants from East, North and South Ayrshire, aged five years and over, in a festival of accessible football, where fun came first and everyone had a chance to shine on the pitch.



"Dozens of activities were on offer, each designed to be accessible for players with a range of mild to severe physical and/or learning disabilities. This allowed parents and carers the opportunity to connect with other families navigating similar challenges.

"Adding to the occasion was a surprise visit from Captain Conker, Kilmarnock Football Club's mascot, bringing smiles and laughs.

"The event was delivered in partnership with a range of local organisations, most notably Ayrshire Sportsability, which played a key role in helping to promote the day and provided volunteers to support everyone across the pitch."

#### **Event celebrates one year of the UNCRC in Scotland**

On 16 July 2024, Scotland became the first devolved country in the world to incorporate the United Nations Convention on the Rights of the Child (UNCRC) into law.

To celebrate the first anniversary of the UNCRC in Scotland, we held a special 'birthday' event at Take A Bow Opportunity Centre in Kilmarnock.

The event was attended by Provost Claire Leitch, along with practitioners from across East Ayrshire and our Community Planning Partners, and also focused on planning the next stages of the East Ayrshire UNCRC journey.

**The UNCRC:** is the base standard for children's rights and sets out the fundamental rights of all children.

It is the most widely ratified human rights treaty in the world and sets out the specific rights that all children have to help fulfil their potential. This includes their rights relating to health and education, leisure and play, fair and equal treatment, protection from exploitation and the right to be heard.

The UNCRC is used as a framework to ensure that children's rights are fully considered whenever we take decisions, and to help provide every child with a good start in life and a safe, healthy and happy childhood.

**Implementation in East Ayrshire:** Within East Ayrshire we are utilising a UNCRC Champions model to allow us to develop a collaborative approach across services to support the implementation of the UNCRC. This work is being supported by the National Quality Improvement team.

While our Champion's model is currently in its early stages, significant work has already been carried out across our children's services that we can build upon.

Our next steps will focus on how children and young people can join the UNCRC journey alongside us and be at the forefront of future service transformation across children's services.

## North Ayrshire Learning Disability Service

The Learning Disability Service will be a key delivery partner in this work, as will a range of other Third Sector organisations within North Ayrshire. This exciting project promises to further advance a shared ambition regarding the greater community inclusion of people with learning disabilities, in their interests and in the interests of communities as a whole.
