# 2. Report summary

#### 2.1 Situation

This paper is presented for Members to approve the NHS Ayrshire & Arran Board meeting dates for the next financial year 2026 to 2027.

## 2.2 Background

NHS Ayrshire & Arran Board meeting dates are published annually a year ahead. This aids planning and arrangements for governance committee meetings. The Board Standing Orders section 4.1 details that the NHS Board approves the Board meeting schedule.

#### 2.3 Assessment

Board meetings take place every two months with six meetings in public and a private meeting agreed in advance to consider and approve the Board's annual accounts. In line with Board Standing Orders the annual accounts meeting is held in private.

A board meeting calendar with deadlines for submission of papers and publication dates will be issued to Corporate Management Team.

Future meetings will continue with a hybrid approach affording the opportunity for a blend of in person and remote attendance via MSTeams. A review is ongoing to identify suitable venues for full in person meetings during the year.

Planning for Governance Committee meetings is underway. This will take cognisance of the Ayrshire IJB arrangements and reporting requirements to deliver a robust governance schedule in line with risk management and performance reporting timescales. This will also take account of Members' committee responsibilities to deliver a balanced meeting workload wherever possible. These arrangements will inform the Corporate Calendar which will be submitted to a future Board meeting.
